The Author retains all moral and proprietary rights that are not in conflict with the terms of this License. This includes ownership of all patent and trademark rights to any process or procedure, or any other form of intellectual property contained in the Accepted Contribution.

**C. AUTHOR'S WARRANTY**

The Author represents and warrants as follows. That:

- (vi) the named Author has the full power to make this Agreement on behalf of his/her co-authors.
